TERMS AND CONDITIONS

- The customer will use the above mentioned dispensers solely for the purpose of dispensing Pacific Hygiene product supplies exclusively by an authorised Pacific Hygiene Distributor for a period of 3 years.
- The dispensers will remain at all times the property of Pacific Hygiene during this 3 year period, after which they may be purchased for a negotiated fee, or a further contract term entered into.
- Should a breach of this contract occur within 3 years, the customer will purchase the dispensers from Pacific Hygiene for the difference between Total Value and Amount Paid as specified i.e. pay for the dispensers in full. This will include any installation costs either incurred by Pacific Hygiene or the installing Distributor.
- This Dispenser Supply Contract covers the dispensers stated above. Should additional dispensers be required, the completion of a new Dispenser Supply Contract is required.
- Pacific Hygiene will replace at no charge any dispensers which are faulty, unless these have been maliciously damaged or vandalised after installation.
- All Dispenser Supply Contract forms must be returned to Pacific Hygiene Ltd within 60 days of installation.
- This Dispenser Supply Contract will not be treated as a purchase order. If requiring supply, a company purchase order form must be raised.
- In signing this contract you agree to allow Pacific Hygiene to contact you and store your information in their database.
- It is compulsory for all fields on this agreement to be filled in. This information will be retained by Pacific Hygiene Ltd.
- The customer must personally sign the Pacific Hygiene Ltd Dispenser Supply Contract. Not to be signed by a distributing agent.
- In certain circumstances a distributor may also require the completion of an agreement. This distributor agreement in no way affects the terms of this contract.
